CSSA Membership Renewal 2024

Dear Principals,

The Christian Schools Sports Association was formed to foster Christian thought and practice through sporting events within and between Christian Schools.

Without limiting the School's Constitution, Statement of Faith and related documents, which may provide more specific information, the School is an institution established for religious and educational purposes, conducted in accordance with the doctrines, beliefs and/or tenets or teachings of the **evangelical protestant stream of the Christian religion.**

Please ensure you are aware of the following when completing the CSSA Membership Application for 2024:

- the situation for members that are no longer able to **affirm** the CSSA Statement of Affirmation
- the responsibility of members to issue a Risk Warning to students and parents for CSSA events; and
- the need for CSSA to have appropriate **child safety policies** and procedures in place:
 - to support member schools in their commitment to child safety, and
 - to ensure that students can engage in sport through CSSA in a way that prioritises their safety and wellbeing.
- CSSA Public Liability Insurance coverage for state level events only

CSSA was initially set up to serve the Christian school movement from the now CSA and CEN movements. Part of the definition of a Christian school that was assumed was that they were schools that exclusively hired Christian staff who were in regular church attendance.

It is an imperative that the people representing their schools as voting members in CSSA are Christians as they shape the nature and flavor of the association. This initially was not a concern as the assumption was that member schools had this exclusive hiring policy. It has become clear that there are a number of schools that do not follow this policy and makes the assumption of only Christian membership for schools redundant.

The CSSA Committee of Management have the ability to transfer members who can no longer adhere to the Statement of Affirmation ie. **employ Christian teachers who are able to subscribe to this Statement of Affirmation**, from **Full Membership entitlements** to **Provisional Membership entitlements** which has **no voting rights** but can continue to participate in the Association's activities for a specific time. Please see **Annexure A** for a copy of the CSSA Statement of Affirmation.

This will allow schools who may not currently have an exclusively Christian teaching staff for historical reasons and are seeking earnestly to redress this situation to remain in the association. However, if school principals do not see that this is critical in having an authentic "all of life" approach to education, they ought to reconsider their membership of the association in the future.

Risk Warning

One of the risks of participating in sport is injury. Members are being asked to declare that they will provide reasonable notice to students and their parents, guardians or carers of the risk warning set out at **Annexure B** to this application (or one of similar effect). CSSA understandably has limited direct contact with students from member schools and it is expected that this risk warning, or one of similar effect, would be included on consent forms or other notices issued by member schools to parents and students about CSSA events.

CSSA will ask that the member indemnify CSSA relating to any failure on the part of the member school to provide reasonable notice of this risk warning to their students and their parents, guardians or carers. For its part, CSSA will take reasonable steps to ensure the risk warning is visible in reference to CSSA material online and at CSSA events.

CSSA Child Safety Policy

CSSA has recently reviewed its child safety policies and procedures. As a result of that review, the CSSA Committee of Management has adopted the CSSA Child Safety Policy set out at **Annexure C**. The CSSA Child Safety Policy sets out that:

- it is the responsibility of member schools to supervise students in attendance at CSSA events and ensure that member school staff and volunteers have been appropriately screened; and
- it is the responsibility of CSSA to manage certain risks relating to CSSA events to ensure that all CSSA staff and volunteers are appropriately screened.

The CSSA Child Safety Policy also sets out the approach of CSSA to complaints relating to child safety concerns.

We trust that these measures will provide comfort to our members that we take the safety and wellbeing of students seriously, and that our commitment to facilitating sporting events for our members includes a commitment that children would be safe from harm.

CSSA Public Liability Insurance

The CSSA Public Liability Insurance policy is necessary for the organisation to protect itself against claims of negligence made by third parties in relation to injury or property damage arising from the organisation's operations at state level events directly facilitated by CSSA. Claims examples may include allegations of breach of duty, incompetent supervision, or ineffective administration. Due to the nature of the insurance policy school & zone level events are not covered by the association and would need to come under the convenor's school public liability insurance.
